

## **40<sup>th</sup> Meeting of the Council of Permanent Representatives (CPR) of ECOCI**

**September 12, 2023**

### **Draft Report**

The Council of Permanent Representatives of ECO Cultural Institute (ECO CI) convened its 40<sup>th</sup> meeting at the ECO CI Headquarters on September 12, 2023. The meeting began under the chairpersonship of Mr. Seyed Jalaedin Alavi Sabzevari, Permanent Representative of the Islamic Republic of Iran. Ambassadors and representatives of the Islamic Republic of Iran, the Republic of Tajikistan and Republic of Türkiye as well as a delegation of the ECO Cultural Institute headed by ECO CI President attended the Meeting. #### **Agenda item 2**

##### Consideration and adoption of the draft report of the 39<sup>th</sup> ECO CI-CPR meeting

The draft report of the 39<sup>th</sup> ECO CI-CPR meeting, circulated via Note No. ECI/524/362 dated August 16, 2023, was unanimously adopted.

### Agenda item 3

#### Statement by ECOCI President on the ECOCI activities

- Under this item, Mr. Murodjon Buriboev, ECOCI President, made his statement and briefed the Meeting on the activities of the Institute since the last CPR meeting. The statement of the ECOCI President is attached to this report as annex II.

Chair, in the capacity of the Permanent Representative of the Islamic Republic of Iran, expressed gratitude for the efforts made by the ECOCI President to expand the outreach of the Institute and attract more ECO members interested in membership of the ECOCI. The Islamic Republic of Iran holds a positive outlook that Uzbekistan may soon join the ECOCI.

### Agenda item 4

#### Administrative issues:

#### Extension of the tenure of the incumbent ECOCI President until the arrival of the incoming President

Taking into consideration that the extended tenure of the incumbent ECOCI President ended on August 31, 2023, and with reference to the Note Verbale received from the Embassy of the Islamic Republic of Pakistan in Tehran conveying the delayed arrival of the incoming ECOCI President as well as the Note Verbale of the Ministry of Foreign Affairs of Iran, as the current Chairperson of the ECOCI-CPR, proposing extension of the tenure of the incumbent ECOCI President, the ECOCI-CPR considered the matter and made the following decision:

**The ECOCI-CPR recommended to ECOCI's Board of Trustees (BoT) and the ECO's Council of Ministers (CoM) that the tenure of the incumbent President of ECOCI may be extended until the end of September 2023 with retrospective effect as of September 1, 2023.**

**In the absence of BoT and CoM meetings, ECOCI-CPR decided to solicit the consent of all member states through a two-week silence procedure.**

### Agenda item 5

#### Budgetary issues:

- Latest status of contributions and arrears of the ECOCI member states

ECOCI Accounts Officer briefed the meeting on the latest status of contributions and arrears of the ECOCI member states, including their due annual contribution for the year 2023. He referred to the points mentioned in the statement of the ECOCI President and emphasized that the Institute will encounter another financial crisis in the upcoming weeks if no annual contributions from the

member states are received. He further noted that the issue has been indicated in the recent Audit of the ECOCI's accounts.

Acknowledging that the Institute is facing a severe financial crisis and needs assistance, Chair, in the capacity of the Permanent Representative of the Islamic Republic of Iran, assured that the host country will take the necessary measures to repay the arrears of the Islamic Republic of Iran, as the country has already paid \$200,000 during the current year but still owes \$465,000. He further hoped that other members would also do their part by convincing their capitals that the ECOCI deserves expedited repayment of the arrears. That is especially critical as the new ECOCI President is about to take office, and it's essential to have sufficient funds available.

The ECOCI-CPR urged the Institute to inform the member states through a circular Note Verbale conveying the following recommendation of the Council:

- ***ECOCI-CPR acknowledges the concern of the ECO Cultural Institute facing dire financial straits and strongly recommends to the member states to expedite the settlement of their due annual contributions and arrears on an urgent basis, even with partial payments, to avert a major financial crisis.***
- ***The ECOCI-CPR also recommends to the ECO's Council of Ministers (CoM) to recommend to the ECOCI's member states the same as above.***

Chair, also recommended that the proposal made by the Republic of Tajikistan for “writing off its outstanding arrears to the ECOCI's annual budget and increasing its due annual contribution to the Institute by 10 percent” may be shared with the ECO Secretariat to seek their consultation for placing the issue on the agenda of the upcoming CoM meeting.

Regarding the above issue, the ECOCI-CPR reached the decision as follows:

- ***ECOCI-CPR received the proposal of the Republic of Tajikistan and decided to recommend to ECOCI's Board of Trustees (BoT) that the BoT may agree with the proposal made by the Republic of Tajikistan for “writing off its outstanding arrears to the ECOCI's annual budget and increasing its due annual contribution to the Institute by 10 percent”.***
- ***In the absence of BoT, ECOCI-CPR decided to solicit the consent of all member states through a two-week silence procedure.***

Representative of the Republic of Türkiye informed that the Embassy previously requested the Ministry of Culture and Tourism of the Republic of Türkiye for the payment of the member state's due contribution but has not received any instructions yet. The Embassy will remind the Ministry about the urgency of the matter and will provide the ECOCI with an update afterward.

## **Agenda item 6**

### Latest update on holding 7th meeting of the ECOCI Board of Trustees (BoT)

Representative of the Islamic Republic of Iran informed that the Ministry of Culture and Islamic Guidance of Iran has proposed holding the meeting in either November or early December of the current year. The esteemed member states are requested to inform the host country or the Institute about their level of participation, as this is a ministerial meeting and it is preferable to have ministers in attendance. The exact date of the meeting will be confirmed in the near future.

Chair emphasized that the Ministry of Culture and Islamic Guidance of the Islamic Republic of Iran is determined to organize the BoT meeting in 2023 and expressed hope that the highest level of participation and maximum number of countries attend the meeting. The attendance of all ministers is crucial, as it will send a message to the other ECO member states that the ECOCI is in place and there is a strong commitment among the five member countries to expand the membership of the Institute. This will encourage other ECO member countries to consider joining the ECOCI and will help the ECOCI have a higher profile of cultural activities.

## **Agenda item 7**

### Progress report on “ECO Youth Award”

ECOCI Executive Director provided an update to the Council, announcing that the ECO Youth Award theme for this year is graphic design, which appeals to young people. Registration started on August 20 and the submission deadline is on October 20. The awards ceremony will take place on November 20. Banners and posters are being designed and will be shared with member states, where they will be sent to universities and cultural institutes to promote the event. Promotional materials will be produced in Persian, English, and Russian languages. A sponsor has been secured for the event. Furthermore, a Note Verbale will be circulated among the member states requesting their assistance in holding the festival on November 20. The hope is that member countries will inform their cultural and educational centers to encourage maximum participation of the youth of ECO member countries in this festival.

## **Agenda item 8**

### Any other business

ECOCI Executive Director highlighted the establishment of a committee to review the ECOCI's proposal on the scale of assessment of contributions by the member states. He further explained that a Note Verbale has been sent to member states informing them of the upcoming committee meeting. The ECOCI's proposal comprises two alternatives: one based on the fixed rate of payment and the other based on revising the scale of assessment for all members, as proposed by the Islamic Republic of Iran and the Republic of Türkiye.

The ECOCI Executive Director invited all the member states to participate in the committee meeting, which offers a valuable opportunity to discuss the proposal.

Chair referred to the first scenario for the Scale proposed by the ECOCI which is based on the fixed rate of payment and noted that it is not advisable to have fixed contributions when there is potential for the Institute to expand.

Chair clarified that the scale of assessment and the size of the budget are two separate matters. The member states must come to an agreement on the scale of the assessment for a period of three years, while the budget size can be adjusted annually in proportion to the Institute's activities. If the Institute's membership grows, its activities will expand accordingly. Therefore, the focus should be on deciding the percentage of contribution rather than fixed figures. However, it is important to review the Scale of Assessment every three years.

He noted that the use of the term "founding members" has been discontinued in the ECO Secretariat. Instead, it is proposed that Iran, Pakistan and Türkiye contribute a specific percentage of the budget while the remaining will be divided among the other member states. Furthermore, the Institute should establish a provisional formula in place for when a new member joins the ECOCI. All members are highly encouraged to attend the committee.

He suggested that the ECOCI consult with the ECO Secretariat as well to develop a feasible scale of assessment for three years.

#### Date and venue of the next meeting

Chair stressed that another ECOCI-CPR meeting is needed before the distinguished ECOCI President leaves. The date and venue of the meeting will be shared soon. The availability of all ambassadors will be checked to ensure they are present for the ECOCI-CPR and a farewell ceremony for the president. The ceremony may be held during the ECO-CPR meeting, but this is yet to be finalized. If it cannot be held during the ECO-CPR meeting, another meeting will be arranged. The Islamic Republic of Iran, as the current Chairperson of the ECOCI, may host the ceremony.

Therefore, the esteemed member states are requested to kindly take necessary measures for acceleration in payment of their due contribution and outstanding arrears. The details of the latest status of payments and arrears of the member states will be provided under the relevant agenda item.

Dear colleagues,

We have recently informed the esteemed member states via circular a Note Verbale about the meeting of the working group to formulate a new Scale of Assessment of Contribution by the member states to the ECOCI's budget for the year 2024. Furthermore, a draft proposal for the new Scale of Assessment has been circulated among the members to be discussed during the planned meeting. The esteemed member states are requested to kindly take part in the meeting of the Working Group as scheduled.
